## **Description of the Planned Network Change(s):**

Verizon will be realigning the E9-1-1 data and voice network and facilities for the carriers mentioned above at the locations mentioned above. The E9-1-1 database platforms used by all carriers mentioned above, other than in the States of Florida, Texas and California, will be installed at the Fort Wayne, IN data center and the Everett, WA facility set forth above. Database platforms for the States of FL, TX and CA will be located at the Long Beach, CA data center and Tampa, FL data center set forth above.

Except for certain CA and NV Public Safety Answering Points (PSAPs) further described below, PSAP circuits served by the carriers mentioned above will be migrated to the new database platforms at Fort Wayne, IN and Everett, WA. PSAP circuits served by the States of FL, TX and CA will be migrated to the database platforms at Long Beach, CA data center and Tampa, FL data center.

Certain PSAP(s) serving specific customers at Gardnerville, NV and Blythe, CA will migrated from database platforms at Everett, WA and Long Beach, CA to databases at Tampa, FL and Long Beach, CA.

## **Description of Reasonably Foreseeable Impact(s) of the Planned Change(s):**

Interconnecting carriers and PSAPs served by the carriers mentioned above will need to establish or move 911 circuits to new database platforms at Fort Wayne, IN, Everett, WA, Long Beach, CA and/or Tampa, FL.
