**Subject : Verizon Partner Solutions Industry Letter: Delmar, NY 5ESS Switch Retirement**

**PLEASE NOTE:**

- All references to the Delmar, NY 5ESS switch are associated with CLLI code DLMRNYDADS0 and will not be repeated throughout this letter.
- All references to the Albany, NY Packet End Office (PEO) switch are associated with CLLI code ALBYNYSSPS1 and will not be repeated throughout this letter.

As set out in the Verizon New York Inc.Public Notice of Network Change Under Rule 51.329(a), dated December 1, 2022, on or after July 3, 2023, the Delmar, NY 5ESS switch will be retired and removed from the Verizon network as part of ongoing efforts to modernize the network.

**General Information:** The Exchange Codes (NXXs) in Numbering Plan Area (NPA) 518 currently residing in the Delmar, NY 5ESS switch (see list in Table B below) will be moved to the Albany, NY PEO switch (see details in Table A below).

The native NPA NXXs belonging to the Delmar, NY 5ESS switch will be rehomed upon decommissioning of the switch and reflected in the Local Exchange Routing Guide (LERG) for the Albany, NY PEO switch. This will occur on or after July 3, 2023.

**Network Changes and Trunk Rearrangements:**

The Albany, NY PEO switch will be the recipient office of traffic migrated from the Delmar, NY 5ESS switch. Traffic bound for the codes listed in Table B will be delivered via the Albany NY Tandem (ALBYNYSS5GT intra-lata SHA/ALBYNYSS5GT inter-lata FG Access SHA).

After all traffic is migrated off of the Delmar, NY 5ESS switch, it will be retired and removed from the network.

CLECs, IXCs, IECs, wireless carriers and paging carriers will need to secure new trunk groups built to the Albany, NY PEO switch or have existing trunk groups to that switch augmented. Carriers that have direct end office trunks (DEOT) with access connectivity in the Delmar, NY 5ESS switch will be required to reposition the codes to the Albany, NY PEO switch.

All ASRs for the Albany, NY PEO switch must be received no later than May 15, 2023 to provide sufficient time to migrate the

traffic described above. All traffic must be moved by July 3, 2023. All ASRs for the Albany, NY PEO switch must carry the project code of **DLMRNYDADS0**.

Please adhere to industry standards using normal procedures that pertain to updates and changes to the LERG for all NXXs subject to the retirement of the Delmar, NY 5ESS switch.
