Subject : Verizon Partner Solutions Industry Letter: Mamaroneck NY 5E Switch Retirement

PLEASE NOTE:

- All references to the Mamaroneck NY 5E switch are associated with CLLI code MMRNNYMADS0 and will not be repeated throughout this letter.
- All references to the Pleasantville NY switch are associated with CLLI code PSVLNYPVPSA and will not be repeated throughout this letter.

As set out in the Verizon New York LLC Public Notice of Network Change under Rule 51.329(a) dated April 12, 2023, on or after December 1, 2023, the Mamaroneck NY 5E switch will be retired and removed from the Verizon network as part of ongoing efforts to modernize the network.

General Information: The Exchange Codes (NXXs) in Numbering Plan Area (NPA) 914 currently residing in the Mamaroneck NY 5E switch (see list in Table B below) will be moved to the PSVLNYPVPSA switch (see details in Table A below).

The native NPA NXXs belonging to the Mamaroneck NY 5E switch will be rehomed upon decommissioning of the switch and reflected in the Local Exchange Routing Guide (LERG) for the PSVLNYPVPSA switch. This will occur on or after December 1, 2023.

Network Changes and Trunk Rearrangements:

The Pleasantville NY DMS switch will be the recipient office of traffic migrated from the Mamaroneck NY 5E switch. Traffic bound for the code listed in Table B will be delivered via the White Plains 08T Tandem (WHPLNYWP08T intra-lata SHA / WHPLNYWP08T inter-lata FG Access SHA).

After all traffic is migrated off of the Mamaroneck NY 5E switch, this switch will be retired and removed from the network.

CLECs, IXCs, IECs, wireless carriers and paging carriers will need to secure new trunk groups built to the Pleasantville NY DMS switch or have existing trunk groups to that switch augmented. Carriers that have direct end office trunk (DEOT) with access connectivity in the Mamaroneck NY 5E switch will be required to reposition the codes to the Pleasantville NY DMS switch.

All ASRs for the PSVLNYPVPSA switch must be received no later than October 1, 2023 to provide sufficient time to migrate the traffic described above. All traffic must be moved by December 1 2023. All ASRs for the Pleasantville NY DMS switch must carry the project code of **MMRNNYMADS0**.

Please adhere to industry standards using normal procedures that pertain to updates and changes to the LERG for all NXXs subject to the retirement of the Mamaroneck NY 5E switch.
