## Subject : Verizon Partner Solutions Industry Letter: Gaskins Road, VA 5E Switch Retirement

### PLEASE NOTE:

- All references to the Gaskins Road VA 5E switch are associated with CLLI code RCMDVAGKDS0 and will not be repeated throughout this letter.
- All references to the Grace Street VA CS2K switch are associated with CLLI code RCMDVAGRPS1 and will not be repeated throughout this letter.

As set out in the Verizon Virginia LLC Public Notice of Network Change under Rule 51.329(a), dated June 14, 2023, on or after January 2, 2024, the Gaskins Road VA 5E switch will be retired and removed from the Verizon network.

**General Information:** The Gaskins Road VA 5E switch will be replaced by the Grace Street VA CS2K switch. See details in Table A.

The Exchange codes (NXXs) in Numbering Plan Area (NPA) 804 currently residing in the Gaskins Road VA 5E switch will be rehomed upon decommissioning of the switch and reflected in the Local Exchange Routing Guide (LERG) on or after January 2, 2024. See details in Table B.

### Network Changes and Trunk Rearrangements:

The Grace Street VA CS2K switch will be the recipient of office traffic migrated from the Gaskins Road VA 5E switch. Traffic to be migrated to the Grace Street VA CS2K switch includes all of the traffic currently handled by the Gaskins Road VA 5E

switch including, but not limited to, inter-LATA access traffic (including Feature Groups B and D traffic), and intra-LATA and local traffic (including CLEC, IEC, wireless and Verizon sector endoffice switched traffic). After all traffic is migrated off of the Gaskins Road VA 5E, this switch will be retired and removed from the network.

All CLECs, IXCs, IECs, ILEC, wireless carriers and paging carriers will need to provision new trunk groups to support direct end-office trunking to the Grace Street VA CS2K switch. Carriers with existing trunk groups to this switch will need to augment if necessary.

All ASRs for the Grace Street VA CS2K switch must be received no later than **November 13, 2023** to provide sufficient time to migrate the traffic described above. All traffic must be moved on or after **January 2, 2024** based on LERG change notification. ASRs for the Grace Street VA CS2K switch must carry the project code of **RCMDVAGKRP0**.

Upon decommissioning of the Gaskins Road VA 5E switch, the six (6) native codes (NPA NXXs) that currently reside in the Gaskins Road VA 5E switch will reflect the Grace Street VA CS2K switch in the LERG.

Submission of disconnect ASRs to Verizon for the Gaskins Road VA 5E switch are required immediately after the re-homing of traffic is complete.

Please adhere to industry standards using normal procedures that pertain to updates and changes to the LERG for all NXXs subject to the retirement of the Gaskins Road VA 5E switch.
