**Subject : Verizon Partner Solutions Industry Letter: Jefferson PA EWSD Switch Retirement**

**PLEASE NOTE:**

- All references to the Jefferson PA EWSD switch are associated with CLLI code PHLAPAJEDS0 and will not be repeated throughout this letter.
- All references to the Market PA C20 switch are associated with CLLI code PHLAPAMKPS2 and will not be repeated throughout this letter.

As set out in the Verizon Pennsylvania LLC Public Notice of Network Change Under Rule 51.329(a), dated January 31, 2024, on or after September 3, 2024, the Jefferson PA EWSD switch will be retired and removed from the Verizon network as part of ongoing efforts to modernize the network.

**General Information:** The Exchange Codes (NXXs) in Numbering Plan Area (NPA) 215 currently residing in the Jefferson PA EWSD switch (see list in Table B below) will be moved to the Market PA C20 switch (see details in Table A below).

The ten (10) native NPA NXXs belonging to the Jefferson PA EWSD switch will be rehomed upon decommissioning of the switch and reflected in the Local Exchange Routing Guide (LERG) for the Market PA C20 switch. This will occur on or after September 3, 2024.

**Network Changes and Trunk Rearrangements:**

The Market PA C20 switch will be the recipient office of traffic migrated from the Jefferson PA EWSD switch. Traffic bound for the codes listed in Table B will be delivered via the Market 90T Tandem (PHLAPAMK90T).

After all traffic is migrated off the Jefferson PA EWSD switch, this switch will be retired and removed from the network.

CLECs, IXCs, IECs, wireless carriers and paging carriers will need to secure new trunk groups built to the Market PA C20 switch or have existing trunk groups to that switch augmented. Carriers that have direct end office trunk (DEOT) with access connectivity in the Jefferson PA EWSD switch will be required to reposition the codes to the Market PA C20 switch.

All ASRs for the Market PA C20 switch must be received no later than July 15, 2024 to provide sufficient time to migrate the traffic described above. All traffic must be moved by September 3, 2024. All ASRs for the Market PA C20 switch must carry the project code of **PHLAPAJEDS0**.

Please adhere to industry standards using normal procedures that pertain to updates and changes to the LERG for all NXXs subject to the retirement of the Jefferson PA EWSD switch.
