Subject : Verizon Partner Solutions Industry Letter: East 37th St. 3 NY 5E Switch Retirement

PLEASE NOTE:

- All references to the East 37th St. 3 NY 5E switch are associated with CLLI code NYCMNY37DS7 and will not be repeated throughout this letter.
- All references to the Pearl St. NY C20 switch are associated with CLLI code NYCMNYPSPS1 and will not be repeated throughout this letter.

As set out in the Verizon New York Inc. Public Notice of Network Change Under Rule 51.329(a), dated April 28, 2025, on or after November 1, 2025, the East 37th St. 3 NY 5E switch will be retired and removed from the Verizon network as part of ongoing efforts to modernize the network.

General Information: The Exchange Codes (NXXs) in Numbering Plan Areas (NPAs) 212, 646, and 917 currently residing in the East 37th St. 3 NY 5E switch (see list in Table B below) will be moved to the Pearl St. NY C20 switch (see details in Table A below).

The native NPA NXXs belonging to the East 37th St. 3 NY 5E switch will be rehomed upon decommissioning of the switch and reflected in the Local Exchange Routing Guide (LERG) for the Pearl St. NY C20 switch. This will occur on or after November 1, 2025.

Network Changes and Trunk Rearrangements:

The Pearl St. NY C20 switch will be the recipient office of traffic migrated from the East 37th St. 3 NY 5E switch. Traffic bound for the codes listed in Table B will be delivered via the 37th St. NY 23T 5E tandem local and LD FG (NYCMNY3723T intra-lata SHA / inter-lata FG Access SHA).

After all traffic is migrated off the East 37th St. 3 NY 5E switch, this switch will be retired and removed from the network.

CLECs, IXCs, IECs, wireless carriers, and paging carriers will need to secure new trunk groups built to the Pearl St. NY C20 switch or have existing trunk groups to that switch augmented. Carriers that have direct end office trunk (DEOT) with access connectivity in the East 37th St. 3 NY 5E switch will be required to reposition the codes to the Pearl St. NY C20 switch.

All ASRs for the Pearl St. NY C20 switch must be received no later than September 1, 2025, to provide sufficient time to migrate the traffic described above. All traffic must be moved by November 1, 2025.

Please adhere to industry standards using normal procedures that pertain to updates and changes to the LERG for all NXXs subject to the retirement of the East 37th St. 3 NY 5E switch.
